“National IP Pendency Elimination Karma-Mission (NIPEKM)”

In furtherance of the vision of liquidating the critical pre-examination pendency of Trade Mark applications in the Trade Marks Registry (TMR), a National IP Pendency Elimination Karma Mission (NIPEKM) has been launched for a period of Ten (10) weeks, culminating on 26th April 2026 (World IP Day).

This Order is issued in continuation of Office Order No. CG/F/CGPDTM/DL-10/1274 dated 08.10.2025 as amended by Office Order No. CG/F/CGPDTM/DL-10/1274-(A) dated 13.10.2025.

All officers of the Trade Marks Registry as listed in Annexure-I (Names of Officers) and assigned targets in Annexure-IV (Assigned Targets) are hereby directed, as an interim and immediate measure, to examine 60 cases per day in order to fulfill the objectives of the Mission.

As part of this special Mission, all officers at all locations as per Annexure-II, at the level of Examiner, Senior Examiner, Assistant Registrar, Deputy Registrar, Joint Registrar of Trade Marks, Geographical Indications (GI) & Copyright, including those posted in TMR (including officers working in/ as Administration, Establishment, DDO, System Administrator, Madrid Division, or any other Section), GI Registry, Copyright Office, or Office of the CGPDTM who have not already been specifically assigned Examination of National Trade Mark Applications work under this Order, are hereby directed to perform Examination of National Trade Mark Applications work for one (01) day per week for the next Ten (10) weeks.

Officers as mentioned in Annexure-II, who are presently conducting scheduled hearings four (04) days per week shall also undertake the above additional Examination task for one (01) day per week (Friday) for the next Ten (10) weeks.

Officers listed in Annexure-III shall constitute a panel of Reserved Show Cause Hearing Officers. They shall conduct hearings in cases where assigned Show Cause Hearing Officers are unavailable due to leave or other administrative exigencies.

The System Administrator and IT Division of TMR are directed to provide necessary access to the Examination Module to all officers concerned to facilitate compliance with this Order.

This Order does not supersede the allocation of additional functions/duties being discharged by officers under earlier Office Orders issued with the approval of the Controller General of Patents, Designs and Trade Marks.

Notwithstanding anything stated above, the functions and duties assigned herein may be modified from time to time with the authorization of the Controller General of Patents, Designs and Trade Marks.

The IT Department is hereby directed to monitor the performance of the officers on a daily basis and to submit a consolidated daily performance report to the Heads of Trade Marks at all Offices and to Dr. Pawan Kumar Pandey, Joint Registrar of Trade Marks, GI & Copyright, who shall oversee and monitor the implementation and progress of the Mission.

The revised functional duties and enhanced performance targets prescribed herein shall come into force with immediate effect.
